## PERFORMANCE LICENSING AGREEMENT

1. *Troubled House* is copyright © 2001 Daniel Schwabauer, and may not be presented without the written permission of the author. **You must purchase playbooks for your cast, production and backstage staffs, unless specific written authorization to make limited production copies of the play is granted by the author.** The number of playbooks required will be determined by the cast and backstage requirements for each production. *It is a violation of federal copyright law and international treaties to reproduce copyrighted material, in any form, without the written permission of the copyright owner.*

2. Whenever *Troubled House* is presented in any form (full-production, limited production, staged-reading, etc.), at any level (equity, non-equity, community theater, college, school, etc.), whether by amateurs or professionals, and regardless of whether the actors are paid or unpaid, **the following notices MUST appear on all related printed materials including programs, advertising, etc.:** “Produced by special arrangement with the author” and “www.troubledhouse.com”. **Furthermore, the author MUST be fully credited in bold-face type on all such materials.**

3. **A production photo and a copy of all playbills, programs, print advertising, and reviews must be sent to the author at the address listed below** at the end of the production run agreed to in this license.

4. Royalties are due automatically whether or not the admission is charged if any spectator observes the play, including parents or other classes not involved with the production. Royalties for amateur productions (community theater, college, high school, etc.) are \$60 per performance, due in advance. This performance license will be considered invalid if royalty payments and a signed copy of this contract are not received by the author prior to the performance. Please secure licensing as early as possible to prevent possible performance-date conflicts. Guarantee of performance dates cannot be secured until royalty payments are received.
